 - Individual Case Safety Reports (ICSRs) in XML format divided into
 - Initial ICSR
 - Follow up ICSR
 - Literature review report with different search options
- You can use as an internal reporting tool inside the company to receive PV reports.

Their fitness for purpose:

- PV Zoom provides tool to record unlimited ICSRs received either spontaneously or non- spontaneously & allows company Zoom team to
 - Case seriousness
 - Patient details
 - Reporter,
 - ADR detected
 - Company suspected product
- Allow PV Personnel to generate more than version to the same case in case of follow up or new data regarding the same case collected.



> PV Zoom generate XML file according to ICH-E2B R3 guidelines that can be received by national authority & imported to their database directly.

Validation

❖ Installation:

It is PV Zoom technical team is responsible of illustrating how to use the program & ensure user ability to use it.

Validation during data entering by Users:

- PV Zoom provides guiding messages for PV team (software users) to validate the type of data entered & avoid moving to the next screen unless main data in the screen is entered.
- Dates will be selected from calendar.
- There four types of views to view data
 - View Kanban
 - View pivotView graphView list
- Most fields are dropdown lists.
- Texts boxes are fields that the user will write freely.
- Each user can choose the language.
- The system can add follower to follow up with users.



Users can make chats with each other.

There is a log file that can display all changes made to ICSR and you can also write a message or notes as guide for yourself.

Validation testing in the National Health Authority database used

Change control:

- o Software change control:
 - It is the responsibility of PV Zoom team & it is not allowed for the user.
 - PV Zoom will release new version in case there is change that affect user.
- o <u>ICSR Change Control:</u>
 - version will be created by sending the case to EPVC.
 - The user can create more than one version for the same case ID in case there is new data entered & finalized by sending it again.
 - Case nullification will be an option for the user.

Nature of testing:

The user will enter test case & generate XML file that will be sent to national authority to check successful receival by National authority database.

Back up procedure:



➤ It will be arranged with the company IT department however back up can be done automatically & customized according to company desires.

Security:

- PV Zoom Flow will be accessed by QPPV/Pv personal through user name & password & we can make restriction access for other users.
- In case there are more than one company related to the same owners or that is related somehow in business, PV Zoom can provide specific access to each company.

Duplicate Checking:

<u>Duplicate alert will be raised if the following items are matched</u> more than once:

- Drug name
- Event "MedDRA"
- Any info about the patients

Reports Generations:

- ➤ Reports from patients or their representatives remain an important element in pharmacovigilance.
- Regulatory requirements, set forth safety monitoring and reporting responsibilities of sponsors and investigators to ensure the safety and protection of human subjects participating in clinical trials.
